Mendon, August 25, 2015. Ted was born in Rochester, NY on November 10, 1926. He was the second of 3 children born to Alfred and Dora Reifsteck. He is preceded in death by his parents and his older brother James. Ted is survived by his loving wife of 63 years, Barbara, and their three sons, Thomas and his wife Amber of Houston, Texas, Jeffery of Cincinnati, Ohio and Daniel of Wakefield, Rhode Island; 12 grandchildren; 5 great-grandchildren; sister, Joan McBride; several nieces and nephews, cousins and friends.

Ted served with the Army Airborne from 1945-47 and then returned home from the Pacific Theater of Operations to attend Cornell University where he excelled at both academics, and collegiate football, lacrosse and boxing. There he met and married Barbara (Bobbie). He went on to graduate from Cornell Law school in 1954 and then moved to Alaska to begin his career as an attorney. In 1957 he and his young family returned to Rochester where Ted joined the law firm of Cully, Corbett and Tanenbaum. He later became a partner in that law firm where he worked for 50 years. Known for his love of the outdoors, Ted enjoyed hunting, hiking, fishing, skiing, sailing, scuba, waterskiing and, maybe most of all, horseback riding with Bobbie in the fields and woods of Mendon Ponds Park. He was a loving father and a faithful husband who was known for his quick witted one-liners, as well as his thoughtful and quiet nature. Ted was known by all as a gentleman who lived a humble life with integrity, honor, curiosity and gusto.
